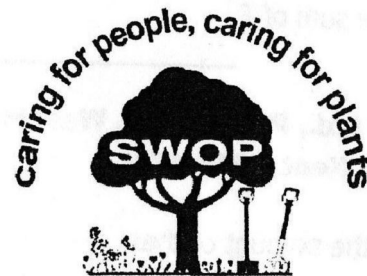

We have spent the last twenty years operating from donated buildings, which are old and dilapidated and are now leaking, damp, smelly and unpleasant. We would love to replace them with truly sustainable low-energy buildings, made from locally sourced natural materials.

This exciting project would be a first for Bournemouth, an asset to the local community and, most importantly, would enhance the lives of our volunteers with severe and enduring mental illness and of everyone who visits our project.
